MANAGER'S REPORT

Today the Conchas Lake elevation is at 4,184.96 feet. Last year at this time the elevation of Conchas Lake was 4,196.5 feet. Conchas Lake received 1,125 acre feet of inflow for the month of February and evaporation and other losses were 2,099 acre feet.

The cleaning of the pond and applying bentonite to the outdoor classroom is completed. The Canadian River SWCD has been invoiced for the work.

The John Deere Backhoe repairs to the front wheel drive and the pins and bushings on the bucket arm are completed.

The Hudson canal from Check 6 to Galvan crossing has been cleaned out. Craig has 3-5 more days of removing sediment upstream of the Galvan crossing to Check 5.

The men have started the burning of the canals. They have completed all of A Unit and B Unit. The wind has not cooperated much with our burning program. We are still looking for a larger water truck for fire protection.

In April, we will have Arch Hurley's draft 2020 operating budget for your review and approval the following month.

This year in October is the Arch Hurley District Board members election. The last Friday in July is when completed signed positions are due in the office. Donna will be working of the legal notices and advertisements that are required for this board election.

Manager McCasland was asked when he thought water might be turned on and he replied the third week in April. For a water order to be valid it has to be ordered for three days. There is deep moisture, but not at shallow depths.

REVIEW PRIOR YEARS ALLOCATION AND CURRENT WATER ALLOCATION

Included in the board packet, there is documentation of yearly water allocation going back to 1959, reservoir and weather report for 2018, 2016 and 2001. The delivery efficiency data chart was included also.

REVIEW OF CONCHAS LAKE ELEVATION AND ALLOCATION FOR 2019

Manager McCasland stated that the elevation of Conchas Lake is 4184.96. Director Perkins made the motion to not allocate any additional water at this time. The motion was seconded by Director Griffiths. Motion carried 5-0.

NM GAME & FISH AND DUCKS UNLIMITED REGARDING TUCUMCARI LAKE

Correspondence with Alan Hamilton indicated his interest in exploring the possibility of reestablishing Tucumcari Lake as a functional lake/wetlands for consumptive and non-consumptive recreational use. Thru a court order, Arch Hurley is required to pump water out of Tucumcari Lake if the elevation is above 4009. Manager McCasland will keep the board informed on this subject.

PROTEST OF WELL APPLICATION IN THE TUCUMCARI UNDERGROUND WATER BASIN

Director Mitchell made the motion to not protest the application of Tucumcari Mountain Cheese Factory, Inc. for permit to appropriate groundwater in the Tucumcari Underground Water Basin. The motion was seconded by Director Henson. Motion carried 5-0.
