MANAGER'S REPORT

Today the Conchas Lake elevation is at 4,174.4 feet. Last year at this time the elevation of Conchas Lake was 4,186.3 feet. Conchas Lake received 1,711 acre feet of inflow for the month of December and evaporation and other losses were 1,215 acre feet.

The radial gate on the Welms waste way has been removed and primed. We have rebuilt the lower part of it and will paint and replace the gaskets.

The legislation to change the Arch Hurley election is now drafted. It totals 272 pages. This is a major change from the current way Arch Hurley elections are held. I will be in Santa Fe during the committee hearings to speak against this bill. I will let the board know the senate and house bill number whenever the bill is submitted. We all need to call our senators and representatives and ask them to not support this legislation.

Arch Hurley is currently advertising and accepting applications for temporary help in the maintenance department.

We purchased a new fire pump and engine for the water truck that was down during our burning season last year. The other two trucks are serviced and ready to run when it is time to start burning this year.

Donna has spoken with our new auditor and his plan is to be here the last of January and the first part of February to complete AHCD 2016 audit.

Arch Hurley will research and start filing liens this month on Class A property that is 3 years or more delinquent in past assessments.

The men are working on the maintenance repairs throughout the district. They are replacing two culverts on the Benson Lateral at this time.
