MANAGER'S REPORT

Today the Conchas Lake elevation is 4,185.2 feet. Last year at this time the elevation of Conchas Lake was 4,196.3 feet. Conchas Lake received 1,943acre feet of inflow for the month of December and evaporation and other losses were 2,255 acre feet.

Craig Hoffman and the maintenance men are working between tunnels 3 and 4 south of the narrows. They had hoped to move to the north side of the narrows around the first part of the year, but the weather did not allow that to happen.

We ordered a semi load of bentonite to be used in some of the seeping areas of the delivery system.

Arch Hurley has received our reimbursement from last year's Capital Outlay appropriation.

The 2019 legislative session will start on January 15 and Quay Day in Santa Fe is on January 16th at the Inn of Loretto.

Director Perkins asked the location of where the bentonite will be used. Manager McCasland stated that half will be used on a dirt ditch near Carolyn Franklin's place.
