# MANAGER'S REPORT

Today the Conchas Lake elevation is at 4,174.1 feet. Last year at this time the elevation of Conchas Lake was 4,163.75 feet. Conchas Lake received 1,192 acre feet of inflow for the month of August. The evaporation and other losses were 4,681 acre feet. Diversion for AHCD in August was 7,283 acre feet.

We had to replace the rubber tracks for the small John Deere excavator.

The ditch riders in F-Unit and G-Unit have resigned. I am going to wait until spring to fill those two positions.

The irrigation water is taking 48 hours to arrive at County Line Check. It usually took 24 hours prior years. The area around Bascom Cut has a large amount of woody vegetation and silt in the canal. The maintenance crew will address this issue when it dries up this winter.

#### REVIEW CONCHAS LAKE ELEVATION

Manager McCasland stated that the elevation of Conchas Lake is 4,174.1 feet.

## BUREAU of RECLAMATION REPAYMENT BALANCE

Manager McCasland reported AHCD's annual construction payment of \$58,255.00 was submitted to BOR. Our current balance is \$1,102,246.72.

#### UPDATE ON AHCD INVESTMENTS

Manager McCasland reported AHCD had closed a CD with Everyone's Federal Credit Union, and reinvested the money by opening a CD with Tucumcari Federal Savings & Loan.

Arch Hurley Conservancy received an insurance check for damages to the office and shop from the May 25<sup>th</sup> hail storm. AHCD will start collecting bids for a new roof on both the office and shop.
