MANAGER'S REPORT

Today the Conchas Lake elevation is at 4,173.9 feet. Last year at this time the elevation of Conchas Lake was 4,163.5 feet. Conchas Lake received 2,695 acre-feet of inflow for the month of September. The evaporation and other losses were 2,949 acre-feet. Diversion for AHCD in August was 3,564 acre feet.

The Conchas irrigation gate was opened again on October 2nd. AHCD had 40cfs in water orders. We started water deliveries on the 4th in the A Unit and on the 7th in the G Unit.

The maintenance men have mowed in some of the units and bladed the bad areas on the canal roads. They hauled in dirt to fill in low areas so the water would drain off of the road.

REVIEW CONCHAS LAKE ELEVATION AND WATER ALLOCATION

Manager McCasland stated that the elevation of Conchas Lake is 4,173.9 feet.

Director Mitchell made the motion not to allocate any more water for the 2023 irrigation season. The motion was seconded by Director Box. Motion carried 5-0.
