### **MANAGER'S REPORT**

Today the Conchas Lake elevation is at 4,172.0 feet. Last year at this time the elevation of Conchas Lake was 4,163.4 feet. Conchas Lake received 154 acre feet of inflow for the month of November. The evaporation and other losses were 1,749 acre feet.

The Ditch Riders have tied up the boards on all of the checks in their units. They are working on replacing leaking irrigation gates. They are building a new radial wasteway gate at the Jack County Check.

The maintenance department has been working on replacing the Keefer and Wheeler Lateral that come off of the Bell Lateral with PVC pipe. This will eliminate over two miles of open ditch and save AHCD on maintenance upkeep and evaporation. It will increase the delivery efficiency in this area to the farmers.

All AHCD pickups and equipment have been winterized and water pumps are drained.

AHCD has switched to Plateau for our phone service for the office. Plateau installed new phones in the office and a conference phone.

The 2023 irrigation water program has been closed for the year. AHCD will issue water credit checks in January.

#### REVIEW CONCHAS LAKE ELEVATION

Manager McCasland reported Conchas Lake's elevation is currently at 4,172 feet.

### REVIEW OF OCTOBER AND NOVEMBER WATER DELIVERY EFFICIENCY

Manager McCasland reviewed the water efficiency reports with the board for the 2023 irrigation water season.
