MANAGER’S REPORT

Today the Conchas Lake elevation is at 4,190.4 feet. Last year at this time the elevation of Conchas Lake was 4,172.5 feet. Conchas Lake received 14,300 acre feet of inflow for the month of June. The evaporation and other losses were 5,051 acre feet. Diversions for Arch Hurley in June was 7,001 acre feet.

Irrigation water delivery for the month of June was very light compared to previous years in June. Most of this is due to the cooler days and the monsoon rains across the irrigation project.

With the lower flows in the Conchas Canal and Hudson Canal we are having to treat for moss and algae throughout the project.

The maintenance department has been out mowing and spraying woody vegetation on the canals.

REVIEW CONCHAS LAKE ELEVATION

Manager McCasland stated that the elevation of Conchas Lake is at 4,190.4 feet.


